RE: 2011 ISAA Breeder Agreement

The BRCC has worked hard to make the ISAA breeder agreement more streamlined and user friendly. We have made a few updates/changes this year in that spirit and we are simplifying the breeder pages as well.

Please note that the BRCC refer to owners of any breeding dog or bitch as breeders so use that generic term to describe both. Approved breeders are listed on the ISAA breeder pages of the club website at no charge. Beginning in 2011, breeders may choose whether they want to list a litter on the ISAA website and/or have a blinking link to their website/puppy page/blog announcing a litter. All links to breeder websites, blogs and/or any ISAA litter listing will also be free of charge.

Breeder listings, links and litter listings require verified health tests. Litter listings will continue to be moved from planned to future to current depending on whether the litter is planned, mated (future) or the litter has arrived (current). There is no requirement that **both** the breeder and stud dog owner be an ISAA member or approved breeder/stud dog owner to list a litter. ISAA members may list a litter as long as the requirement in the following paragraph is met. A revised litter listing form is in process and will be posted on the breeder and puppy pages.

Since the breeder listings on the ISAA website is a tremendous free advertising resource offered to approved breeders/stud owners and is of significant financial value, ISAA approved breeders must agree to purchase a one year ISAA membership for the new owner of any puppy sold who lives in the USA.

The BRCC also requests that we be notified of any significant health issues your dogs (whether listed or not) incur and any dogs you import or export for tracking purposes. Health information will not be released without your approval except as general statistics for report purposes. The names of imported and exported ISDs will appear in the annual ISAA reports.

Regarding ISAA approved breeder renewals for 2011, please review the following two pages of the breeder agreement, check the appropriate lines, sign and return by email or regular mail. To be listed as of January 1, 2011, your breeder agreement must be postmarked by or received by December 15th. Late submissions will be added each quarter following the January listings (i.e. April or July). New applications to become an ISAA breeder will be approved and posted after all of the required information is received, usually within two weeks.

2011 ISAA Breeder Agreement

Please check off each requirement as it applies to you. Each of these requirements must be agreed to or met to become an ISAA approved breeder.

1. I apply for a breeder owner listing with the ISAA for the calendar year 2011 for the below listed Icelandic Sheepdog(s) that I own or co-own.
2. I have reviewed and agree to abide by the ISAA Breeder Code of Ethics http://www.icelanddogs.com/Breeders-Code_of_Ethics.html and the ISAA Breeders' Code of Conduct http://www.icelanddogs.com/Breeders_Code_of_Conduct.html .
3. I will follow the rules and regulations of my parent club and national kennel club. For a list of official ISD parent clubs click here <http://www.icelanddogs.com/Links.html>. Note: Since Canada does not currently have a CKC recognized parent club for the ISD Canadian members would follow CKC regulations.
4. I do agree to follow ISIC Guidelines, I do not agree to follow ISIC Guidelines <http://www.icelanddogs.com/ISI-Guidelines.html>
5. I agree to participate in any study designated as a "special health related study" (i.e. cataract grant/study) when asked by the BRCC/ISAA. If I request reimbursement for incurred testing expense for a designated special study, ISAA will pay that expense.
6. I understand that only dogs/bitches two years of age and older will be listed.
7. I am submitting eye test results from 2010 for 2011 They are available for review on the CERF website They are already on file with the BRCC. I understand that CERF results must be submitted to CERF by completing the back of the form and sending it to CERF.
8. I am submitting hip test results They are already on file with the BRCC
 They are on file with OFA.
9. I agree to provide the BRCC with current litter information as per the ISAA checklist for litter information, within 5 months of whelping, and include any past litters for which information has not been previously submitted to ISAA, CKC or FCI parent club as appropriate. http://www.icelanddogs.com/files/ISAA_Checklist_for_Litter_Information.doc
10. I agree that I will purchase ISAA membership for any puppies sold to USA residents at the time of sale. http://www.icelanddogs.com/files/ISAA_MemberApplication_10.pdf
11. The BRCC is aware of all ISDs I own or co-own. If not, that information is included as an attachment to this application.
12. I understand that I can be removed from the website at any time at the discretion of BRCC for failure to comply with these agreements.
13. (For USA CHIC Breeders Only) I understand that to retain the CHIC designation on my breeder listing, all of my listed dogs must have completed CHIC certification within six months of their listing or from 1/1/2011, whichever is later.
